Mr. DeVito presented the report to the committee.

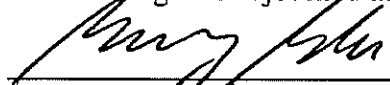

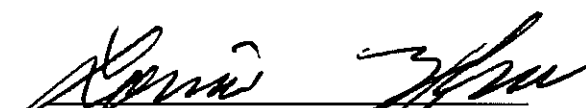
