REGULAR AGENDA – REVIEW/DISCUSS & CONSIDER/ACTION:

1. CONSIDER APPROVING RESOLUTION R11-13 CANVASSING THE RESULTS FROM, MAY 14, 2011 MUNICIPAL ELECTION.

Ms. Brock presented a request to consider accepting the results from the election for At Large Council Member by way of Resolution R11-13. The official results were as follows:

Based on these results Jesse Ancira, Jr. was declared the winner with 607 votes.

Council Member Hill moved to approve Resolution R11-13 as presented and formally accept the canvass of the election and Council Member Gonzales seconded the motion. VOTE: Four voted AYE. Motion passed.

2. ADMINISTER OATH OF OFFICE TO COUNCIL MEMBER AT LARGE.

Municipal Judge Randall Pick administered the oath of office to Council Member At Large Jesse Ancira, Jr..

3. ELECT A MAYOR.

Mr. Hejl presented a call for nominations for Mayor. Council Member Osborn moved to nominate Council Member McDonald as Mayor. Mr. Hejl asked for additional nominations and Council Member Gonzales nominated Council Member Hill for Mayor. Mr. Hejl again asked for additional nominations; hearing none he asked for a vote on the first nomination. VOTE: Two voted AYE (Osborn and McDonald). Motion failed. Mr. Hejl asked for a vote on the second nomination. VOTE: Three voted AYE (Gonzales, Hill, and Ancira). Motion passed and Council Member Hill was declared Mayor.

4. ELECT A MAYOR PRO TEM.

Mr. Hejl presented a call for nominations for Mayor Pro Tem at which time Council

Member Ancira nominated Council Member Gonzales. Hearing no other nominations Mr. Hejl called for a vote. VOTE: Five voted AYE. Motion passed and Council Member Gonzales was declared Mayor Pro Tem.
